Why choose this program?

The study of nutrition and dietetics focuses on the food we eat in relation to the treatment and prevention of a range of important diseases. Students in this program will initially study fundamental health sciences (e.g. anatomy, physiology, biochemistry) before completing more advanced study of human nutrition. The final stage of the program involves practicum placements in hospitals and other health facilities. This program prepares students at the appropriate tertiary level to meet Dietitians Association of Australia (DAA) national competency standards for entry into the profession as a dietitian. Students who graduate from this program will be able establish careers in either clinical, public health or food service nutrition. Increased graduate opportunities exist for private practitioners with the recent introduction of Medicare items for services provided to patients with chronic disease and within the corporate nutrition sector.

This program is available to students who have met the specified progression requirements to undertake Honours.

Attendance information

This program is offered over four years full-time OR four years part-time plus two years full-time at the Gold Coast campus. Students will need to be available full-time to attend professional practice education placement activities in Years 3 and 4.

Student Income Support

To be classed as a full-time student, you are required to enrol in a minimum number of credit points each standard study

period. The minimum credit points for full-time enrolment in this program is 30 credit points.

Trimester 1 and Trimester 2 are deemed standard study periods. As Trimester 3 is a non-standard study period, continuing students moving from one year to the next will not be required to study during this trimester to be eligible for student income support.

Domestic students who commence in Trimester 3 may be eligible for student income support from the onset of study provided they are enrolled full-time in this study period.

Work-integrated learning

Work-integrated learning activities integrate theoretical learning with its application in the workplace. The inclusion of work-integrated learning activities in the degree program demonstrates Griffith's commitment to preparing its graduates for success in their working life. While there is work integrated learning throughout the degree, the major component occurs in the final year.

In this program students will spend time in the work/professional environment undertaking placements at various locations. Placements may be outside of the Brisbane metropolitan/Gold Coast area and (by negotiation) interstate or overseas. In Year 4, students apply the skills and knowledge they have developed across the first three years of the program in a 20 week (750 hour) professional placement, under the supervision of a qualified dietitian with Accredited Practising Dietitian (APD) credentials. Students have the flexibility to choose the trimester in which they undertake the placement.

What are the fees?

Fee-paying undergraduate (domestic) students

Tuition fees
